Brief Description of Undergraduate Courses Taught: (Course Title – Code: Description)

- Nursing Management & Leadership (6 credit hours 3 theory & 3 Clinical) 4th grade. College of Nursing, Dammam University, Kingdome of Saudi Arabia 2016/2017.
 - This course describes the concepts and principles relevant to managerial functions: planning, organizing, staffing, directing and controlling and their application in different nursing situations at the various health care settings. Also, it focuses on the key issues in nursing leadership, concepts and their application into practice. This course will expose the student to the principles of quality management (QM), process of total quality management (TQM) and continuous quality improvement (CQI) and risk management including approaches in identifying and managing health care problem.
 - **Family and Community Health Nursing**, (60 hours theory and 270 clinical practice), 4th grade. College of Nursing, King Faisal University, Kingdome of Saudi Arabia (2008, 2009, UD, 2010, 2011).
- This course prepares the student to participate through nursing actions in all the public health care services provided in the Saudi community. The family, as the primary unit of the community, is the focus of care. This includes health services of preventive, Promotive and curative levels to all members of the family considering their special developmental needs. The student is oriented to use all the available community health resources to accomplish the goals of primary care. Clinical exposure of the student is provided

	through health care centers. The student is required to integrate all previous nursing knowledge and skills to suit the nature of the health problems that may be encountered.
3	Nursing Informatics, (15 hours theory and 90 clinical practice), Bachelor Degree Program, 1 st grade. College of Nursing, King Faisal University, Kingdome of Saudi Arabia (2008, 2009, UD, 2010- 2014).
	This course is designed to provide the student with an introduction to nursing informatics field. Foundations course that emphasis on essential applications in health care informatics and clinical system, which provides understanding of the interdisciplinary issues in nursing informatics. The course focuses on information technologies in health care, nomenclatures, and classification systems, health care documentation, electronic health records, and web-based technologies for health care.
4	Geriatric Nursing 2 credit, Dammam University, 2010-2014.
	The course provides information to prepare the students to provide high quality nursing care of the elderly. It includes theories and concepts of aging, demographic transition, and morbidity and mortality rates among Saudi elderly population. The physiologic and psychosocial changes and problems associated with these process, and the appropriate nursing interventions include nursing care, management, health teaching and utilize appropriate referral to appropriate community resources. Ethical and legal aspects of caring for the elderly are addressed. Application of the nursing process, levels of prevention including health promotion, specific protection measures, early detection, diagnosis and prompt treatment to prevent further complications, disability limitation and rehabilitation.
