Brief Description of Undergraduate Courses Taught: (Course Title – Code: Description)

Contemporary Issues in Public Health (PUBH406): This course discusses updated, emerged, and remerged public health issues in the field of global public health and Saudi Arabia in particular. Students will be able to understand the alternations and changes in this field including new problems, values, ethics, mission, and knowledge about how the public health functions today including the organization, financing, policies, control measures and management practices.

	Public Health Ethics and Laws (PUBH407): The course is covered into three parts. The first part gives an
2	overview of public health ethics and law. Different public health ethics frameworks are in use. The second part applied concepts in public health law and ethics to different areas, including quarantine, substance abuse, disasters and emergences, occupational safety, food safety and nutritional health laws. Health laws governing different institutions and population subgroups are also covered. These groups include refugees, residents, schools, universities, prisons, restaurants, farms, poultries, and abattoirs. In the third part of the course, the concepts covered in parts one and two are applied to Saudi Arabia
3	Health Administration (PUBH301): The course is related to principles of leadership, management, and administration of public health systems, health care systems, hospitals, and hospital networks.
4	Quality of Health Services (PUBH308): This course is concerned with topics and issues relevant to managing quality and safety in public health.
5	Health Care in Saudi Arabia (PUBH 215): The central course question addressed is "What is healthcare in Saudi Arabia?" In learning the answer, the course explores the current structure of healthcare in Saudi Arabia. Critical thinking is an integral part of the exploration in the new era of Saudi 2030 vision, and all this is discussed and applied in the lectures, class activities, and student evaluation.
6	Graduation Project (PUBH 413): This course provides students with the guidance and supervision needed to accomplish a research-based project directed towards the field of public health.
7	Public Health Policy (PUBH 412): This course introduces students to the different models and strategies used to introduce and implement public health policy.
8	Healthcare Finance (PUBH 606): This course provides an overview of health care finance. Financial management, budgeting, accounting, financial statements, and managerial accounting are subjects covered in this course. All these subjects are mandatory, as health care managers must have the financial literacy to make well-informed financial decisions, demonstrate an understanding of financial risk, time value of money, cash flows and budgeting, and improve utilization rates and resource allocation.
9	Health Program Planning and Evaluation (PUBH 622): The course is a useful introduction to the management of health programs. Students learn how to effectively plan, implement, and evaluate health programs. Teaches students how to develop, lead, and evaluate their programs to ensure quality outcomes. The focus is on the three core management concepts of strategy, design, and leadership, but time is also devoted to describing facilitative management activities integral to successful programs. Students will learn techniques for communication, decision-making, quality assurance, marketing, and program evaluation.
10	Public Health Quality Management (PUBH 607): This course is concerned with topics and issues relevant to managing quality and safety in public health. Introduces students to the Baldrige criteria for performance excellence as a framework to improve public health. Explores risk management and change management.
11	Healthcare Marketing (PUBH612): Health care marketing is a new approach to public health that applies traditional marketing principles and theories alongside science-based strategies to diseases prevention, health promotion and health protection. Health care marketing is undergoing dramatic reinvention and change because of emerging trends, reform uncertainties, emergence of social marketing, and renewed focus on quality, outcome, and prevention.
12	Public Health Ethics and Laws (PUBH613): The course is covered into two parts. The first part gives an overview of public health ethics and law. Different public health ethics frameworks are in use. The second part applied concepts in public health law and ethics to different areas including substance abuse, Food Safety and
