Brief Description of Undergraduate Courses Taught: (Course Title – Code: Description)

1 **Principles of Economics (ECON 201)**

This course introduces students to fundamental concepts of economics. It explores both microeconomics and macroeconomics topics such as supply, demand, elasticity, consumer behavior, production, costs, national income accounts, aggregate demand, aggregate supply, inflation, unemployment, fiscal policy, and monetary policy.

2 Quantitative Methods (STAT 306)

This course is designed to guide students with statistical tools to analyze and solve real-world business problems. It will provide students with various statistical concepts and procedures which are essential in making informed business decisions. The course will cover a range of statistical concepts and applications from descriptive analyses to model building and multiple regression analysis.

3 Money and Banking (FIN 308)

This course offers opportunities for students to understand the overview and importance of the financial sector. The emphasis of this course is on the understanding of the financial system, financial institutions, central banks, monetary policy and financial stability. The aim is to give students an overview of the financial system and an understanding of the theory and practice of monetary policy.

4 Training Course (TRA 310)

The training program provides the students with the opportunity to put it into practice. Training plays an important role in student's life. It gives students practical exposure. The student gets an opportunity to apply their knowledge taught in the lecture rooms in real work life situation. The aim of practical training is to help students develop the skills and capabilities that support professional studies and prepare them for their future. The college also has benefited from the program know-how from each respective field of learning, which helps in designing tailored training plans and strategies. For the student, the practical training provides a qualitative opportunity to learn important skills which will help in becoming a professional of the future.

5 Transportation Insurance (INSU 305)



This course provides students with the basic knowledge of transportation, cargo and automobile insurance policies and procedures. It examines the regulations and practices of marine cargo insurance on an international basis and provides practitioners the information required to rapidly and precisely resolves cargo insurance coverage issues, wherever they may arise. The course also investigates how the Institute Cargo Articles have been construed by Courts worldwide. The course covers also transport legislation.
