- Health Economics HIMT 419: The course covers the basic concepts of health economics, such as:the demand and supply of health care, market models and, the different aspects of health care that cause deviation from the perfect market model and market failure, health insurance in general and in Saudi Arabia, the tools used in carrying out the different kinds of cost analysis..
